Re: 2019 Pool Season Information

The 2019 Pool Season will start on Friday May 24th for the Memorial Day Weekend, and will be open daily through Labor Day, September 2nd, 2019. **Pool hours are Monday through Sunday from 11am – 7pm.**

If you already have a photo ID and completed the pool application in 2018:

You will receive 2019 validation stickers in the mail.

If you do not have a photo ID:

Completely fill out and sign the 2019 Membership Application and email to shash@danellarealty.com along with a picture of each family member needing an ID. You may also deliver your Application the management office located in the Clubhouse and have your ID pictures taken there. Applications submitted electronically will be mailed to your home unless you specifically request to pick them up in the office. New residents receive their first pool IDs for free. Replacement passes are \$5 each. *Resident children under 5 do not need pool passes.* All tenants (non-homeowners), should be prepared to show proof of residency.

ID photos should be taken looking straight forward, with no hats or sunglasses. Group pictures may be acceptable if they are clear, and large enough for each face to be cropped. When sending pictures, please label each with the members name(s).

Homeowner accounts must be current with no outstanding fines, dues or violations, otherwise access will not be granted.

Photo ID's and Guest Passes will be distributed during regular management office hours, starting May 1st
Monday – Friday: 9 AM – 5 PM
Wednesdays: 9 AM – 7 PM

GUEST PASSES are \$5 each, or \$40 for 10 (\$10 savings), guest passes do not expire. Lost or damaged guest passes will NOT be replaced. Non-swimming visitors will also be required to obtain a guest pass. Caregiver ID's may be purchased for \$50 and are good for the entire 2019 pool season. Guest pool passes may be obtained directly from the lifeguards and paid for via cash, check or account change form.

If you are a Landlord:

Landlords must have a current lease, lease addendum, Tenant Information Sheet and Rules & Regulations Acknowledgment Form on file for their tenants in order to obtain a pool ID. Landlord and Tenant sections of the Tenant Pool application must be completed and signed by the landlord before returning to the management office before pool access is granted.
